I have been advised that there will be other persons shooting and carrying firearms at 20th Skeet and Clays, and I agree to act prudently and carefully to avoid causing them any injury. I certify that I am familiar with the use and operation of the firearm(s) I will be using while at 20th Skeet and Clays and that I am familiar with the rules of shooting and firearm safety.

I release 20th Skeet and Clays together with all their employees, agents and representatives for any and all claims for personal injury, wrongful death and/or property damage which may arise in my favor and which may occur during or as a result of my presence at 20th Skeet and Clays as referenced above regardless of the cause of any such injury and including those which may be caused by negligence and/or any other cause.

I give this release and assume all the risks attendant thereto in consideration of being allowed to enter into and shoot at 20th Skeet and Clays.

This "release and assumption of risk" will be binding on my heirs, executors and assigns.
