I certify that I am familiar with the use and operation of the firearm(s) I will be using while at 20th Skeet and Clays and that I am familiar with the rules of shooting and firearm safety. I release 20th Skeet and Clays together with all their employees, agents and representatives for any and all claims for personal injury, wrongful death and/or property damage which may arise in my favor and which may occur during or as a result of my presence at 20th Skeet and Clays as referenced above regardless of the cause of any such injury and including those which may be caused by negligence and/or any other cause.

I give this release and assume all the risks attendant thereto in consideration of being allowed to enter into and shoot at 20th Skeet and Clays.
